# Continuing Our Commitment to Excellence and Opportunity: An overview of the proposed budget for 2017-2018

The Board of Education recently approved a proposed budget of \$90,340,742 for the 2017-2018 school year after many discussions throughout the budget development process during the past several months. The adopted budget reflects a 2.1% budget increase, and a 2.9% tax levy increase, with an average 0.6% tax rate increase. The approximate tax impact is \$22 for the average single family home assessed at \$225,000 across the district (tax rates are set in August).

The fiscal plan sustains our investment in teaching and learning, supporting our budget and district goals as we constantly strive to provide value for our community's investment. The proposed budget includes filling staffing positions that have been left vacant over the past several years as we work to meet program demands. Specifically, the budget supports:

- reinstating a full time Orchestra Teacher to address Middle School/High School program demands in the performing arts,
- reinstating a full time Technology Teacher to address district program goals in Computer and Technology coursework including offering national certifications in the building trades and AP Computer Science Principles,
- reinstating full time Teacher Leaders to strengthen our teacher leadership within departments,
- adding a part time English Language Arts instructor at the Middle School to support literacy at the 5th to 6th grade transition,
- maintaining all current district wide athletic, co-curricular and extra-curricular programs at all levels.

The Board is also proposing several propositions on the ballot with the budget proposal which include:

- purchasing vehicles at a maximum cost of \$907,000,
- collecting \$55,650 for Public Library funding, and
- collecting \$30,000 for the Ballston Area Recreation Commission.


Residents are encouraged to learn more about the proposed budget and the school board election before the statewide budget vote on May 16, 2017. Several budget information sessions are scheduled before the vote, including a budget hearing and informational sessions in the community. **Dear Community Members:** 

The Board of Education approved a proposed budget of \$90,340,742 for the 2017-2018 school year which:

- represents a 2.1% increase in expenditures from the current year's budget,
- includes a 2.9% increase to the tax levy, and
- projects a 0.6% increase to the average tax rate across the district (tax rates are set in August).

Throughout the budget process, the Board of Education remained focused on achieving balance between program needs and the fiscal constraints of our community. We focused on the following Budget Goals as we prepared the budget proposal for 2017-18:



Maintain our investment in human capital to build capacity in the workforce and to support the sustained, professional growth of all staff.

**3.** Maintain our commitment to supporting the social and emotional development of our students.

- **4.** Maintain our commitment to supporting access to and implementation of digital resources for students, staff and parents.
- **5.** Maintain the facilities improvement process to support current and future capital projects.

We sincerely appreciate the involvement of everyone throughout our school community as we work together to educate our children. All district voters are encouraged to review the budget information on the website as it outlines historical budget data and provides details on how we, as a community, plan to meet our financial commitments while furthering the district's mission and goals of academic excellence, commitment, value and involvement.

### **Propositions on the Ballot**

In addition to the school budget (which is Proposition I on the ballot) voters will consider the following separate propositions:

### **Proposition II: School Vehicle Replacement**

The district will spend up to \$907,000 to purchase and replace school buses and vehicles.

#### **Proposition III: Ballston Spa Public Library**

The district will be authorized to collect and contribute \$55,650 towards the expense of operating the public library.

### **Proposition IV: Ballston Area Recreation Commission**

A contribution of \$30,000 will be collected and provided to the area recreation commission to support the operations, including Saturday school and summer programs.

### **Board of Education Elections**

There are two full term (three year) and one unexpired term (one year) Board seats up for election this year, commencing in July 2017. The two candidates receiving the most votes will fill the two full three year term vacancies; the unexpired term will be filled by the candidate receiving the third highest number of votes. Interested voters will select from the following candidates at the polls: Jeanne Obermayer, Mike O'Donnell, Lillian McCarthy and Katie Thimineur.

A Meet the Candidates Night will be held in the Ballston Spa High School Library on May 1, 2017 at 6:30 pm so voters may hear from the candidates directly in a program coordinated by students from our Participation in Government classes.

# Facilities Improvement Projects Nearing Completion

The district has been undergoing facilities renovations and upgrades over the past 6 years.

The final improvements approved by the voters last year will be completed this coming summer, including the addition of public restrooms in the old bus garage next to the stadium field for use during events as well as related site work to the adjacent area including drainage, fencing, blacktop, lighting and minor demolition to accommodate maintenance vehicles. The Middle School north parking area will be completely rebuilt with a new subsurface, base, top coat and striping over the summer of 2017. The Middle School Weight Room will be completely renovated to create a new cardiovascular Physical Education station, including new equipment, floor, electrical upgrades, lighting and painting. New equipment has also been secured for the High School Weight Room and dugouts are being planned for the Varsity Softball Field.



### Health and Wellness Expo a Success in Ballston Spa

The annual districtwide event attracted over 300 students, families and community members to learn more about health and wellness. Over thirty health and wellness professionals from area organizations and vendors provided educational information on fitness, healthy eating, and related health and wellness topics. There were fitness and exercise demonstrations, and also exhibits from each of the district's school buildings. Raffles were held throughout the day, including bicycles donated by our BSAC, BSTA and BSATA. Over 165 bicycle helmets were also given away to students by the **Ballston Spa Community Emergency** Corps and Saratoga County Sheriff's Department.

### **SEFCU Penny Harvest Completed by Students**

Students throughout the district collected over \$7,200 during the annual Penny Harvest this past fall, bringing their ten year total to over \$80,300 that students have raised and given back to their community. This year's grant awards will be presented to local charities by the student roundtable groups from each school on May 16, 2017 during the School Pride Day activities in the Ballston Spa High School. The district remains committed to teaching students the importance of service learning and community service throughout the entire school year. ### Teachers' Association Provides Books for Students

The Ballston Spa Teachers' Association (BSTA) is participating in a statewide NYSUT/AFT's Leaders for Literacy program which provides brand new, high quality books to at-risk students in our community. As part of this program, community members complete registration forms which generate brand-new books for the students in our community. The BSTA has now qualified for and distributed over 2,300 brand new books FREE to students in our community. The books have been provided directly to Head Start students; Gordon Creek, Malta Avenue, Wood Road and Milton Terrace elementary students as part of BSTA's Gift of Reading program; to students who attended the District Health Expo and Scotties' Locker; and to students at the Ballston Spa Middle School for the Greek Mythology Unit, Strive for 25 book baskets, and as part of BSTA's Gift of Reading program.

# Student Interscholastic Athletic Accomplishments Winter 2017

Six of our Ballston Spa athletic teams qualified for recognition as a NYSPHSAA Scholar-Athlete Team based on the academic accomplishments of 75 student athletes (combined GPA of 92.46), including the Girls and Boys Indoor Track Teams, Girls Bowling Team, Girls Basketball Team, Cheer Team and the Boys Swimming and Diving Team.

The Wrestling Team had three athletes place in Section 2 Championships, four Class A champions and for the first time in Ballston Spa history, had one athlete earn 1st place at the NYSPHSAA Championships. The team finished as the Suburban Council North Division Champions, the Overall Suburban Council Champions and the Class A Section 2 Champions. The team had four athletes voted All Suburban Council 1st team and one athlete voted All Suburban Council 3rd team. The Varsity and JV coaches both received recognition as Class A Coach of the Year. Congratulations to all!

The **Basketball Teams** had one male and two female athletes selected as Exceptional Senior game participants and one female athlete voted All Suburban Council 3rd team, two athletes selected as Scholar Athlete of the week, and two athletes selected as Time Warner Cable Student Athlete of the Week.

The **Boys Swimming & Diving Team** finished the season with an 8-1 record in the Grey Division, with five swimmers qualifying for the NYS Championships. One swimmer broke a school record and two finished as runners-up in their events at Sectionals.

Our **Girls and Boys Indoor Track Teams** had 18 wins during their competition season this winter.

The **Boys and Girls Bowling Teams** had one athlete qualify for the All Suburban Council 3rd team.
