**CALL TO ORDER**

Mr. Fernau called the Board of Education Meeting to order at 7:00 p.m.

Mr. Fernau stated it was wonderful to be on a positive path regarding COVID levels. He stated the Governor's announcements changed things in the schools. He stated the District was in full gear with activities.

Mr. Fernau thanked parents and care givers for their support. He thanked the District staff members that serve as aids and guide events. He stated the instructional staff goes above and beyond to support students. He stated he hoped the spring would continue down a positive path.

**RECOGNITION**

Mr. Slentz recognized the Saratoga County Chamber of Commerce for their work on the Third Annual Malta Food Fest on December 8th. He stated the community partners are always extremely supportive. He thanked Todd Shimkus, Adrienne Snow and Kelly Delaney-Elliott for their work. He stated December's event had raised over \$5,340. He stated over \$18,000 had been raised over the past three years for partners and innovation initiatives. He recognized Mr. Shimkus as a great partner focused on development and support. He stated his work had generated fantastic resources for students.

Mr. Slentz stated there had been a palpable difference in the energy in the schools today. He shared the day to day positivity happening in the lives of the students. He stated the District had kept things on track and moving forward. He thanked all staff, parents and students. He stated the energy at the dodge ball tournament was representative of today's feelings of positivity.

**BOCES Annual Report**

Mr. Fernau welcomed and introduced the attendees from WSWHE BOCES. The Superintendent of BOCES, James Dexter and Dr. Turina Parker. Dr. Parker talked about the Ballston Spa visitation. She thanked everyone for inviting WSWHE BOCES to the meeting. She shared information about the programs within BOCES, and discussed the available programs and

leadership opportunities. She shared student opportunities for hands on learning and engagement that move students towards successful futures.

Students from the District shared their experiences at BOCES. They talked about the programs they were in and talked about day to day experiences.

Mr. Slentz thanked the students for sharing their experiences.

Mr. Dexter reviewed the information on a hand out regarding programs, data and statistics. He reminded everyone that BOCES supports early college programs in the high schools. He stated BOCES supports all pathways to help kids. He also discussed the Special Needs Programs and other supports available through BOCES.

Mr. Dexter shared the anticipated challenges for the next 3-5 years. He discussed declining enrollment and long-range facilities planning opportunities. He discussed the importance of providing opportunities for women in the trades. He stated it was important for the Districts, guidance counselors and BOCES to partner in the work of engaging young women.

Mr. Dexter shared the ten-year enrollment trend for the component Districts' total enrollment. He stated there were 31 Districts in the BOCES consortium. He discussed the 11<sup>th</sup> and 12<sup>th</sup> grade component enrollment for students attending CTE.

Mr. Dexter shared the overall ETA enrollment trends and Ms. Parker discussed the ETA Divisions and the opportunities for adults. She stated it was great to be able to extend opportunities to adults in the regions.

Mr. Dexter stated internships and vocational opportunities allowed for employers to offer students jobs.

Mr. Dexter shared data and job opportunities for women in the trades. He shared statistical information regarding CTE male / female comparisons by program. He discussed recruiting and support for women and connecting young ladies to the workforce. He stated the low number of women in programs was a systemic issue not just a BOCES issue. He stated everyone needed to help women rethink a career in technical education.

Mr. Dexter stated it was important to expose interested students. He challenged Districts to rethink the orientations for middle schools. He stated it was important to give guidance counselors the training to be prepared to answer parent and student questions past just giving a list of programs available.

Mr. Slentz and Mr. Fernau thanked the individuals from BOCES for their presentations.

**SUPERINTENDENT'S REPORT**

2022-23 Budget Review #2

Mr. Slentz reminded everyone of the District mission. He discussed a meaningful diploma for all students. He discussed the strategic points of focus. Mr. Slentz stated they had remained the same because of the District's long term focus.

Mr. Slentz shared District challenges including shrinking candidate pools and building communications to give rapid responses to combat misinformation.

Mr. Slentz stated long range planning was critical for success. He discussed budget goals, and the 7 strategic points. He stated the District was focused on starting at the earliest learning opportunity to allow the exploration of options and relieve struggling that derails student success.

Mr. Slentz stated it was important for students to explore what they want and don't want before they pay tuition. He stated training and exposure to pathway programs allow for a reduction of student loan debt.

Mr. Slentz discussed the support being provided for students through budget goals, and described MTSS. He also discussed goal for supporting professionals on the District's team. He stated the developmental support allowed the District to become more efficient and effective.

Mr. Slentz discussed the goal to provide support for improvements in facilities, systems processes and protocols. He also discussed training and staffing structure. He highlighted the importance of maximizing aidable services.

Brian Sirianni discussed the functional area of general support items in the budget. He discussed all the parts within the component. He discussed the central offices, facilities and District services that affect all parts of the budget.

Mr. Sirianni discussed IT Support Services changes regarding equipment, software and systems, staff, student support and IT security. He discussed costs relating to IT changes and security.

Mr. Sirianni discussed the facilities component of the budget. He discussed the significant decreases to costs due to updates and renovations. He discussed physical securities that had been put in place and their impact on the budget.

Reopening Plan Update

Mr. Slentz stated new guidance had come out regarding mandate changes. He stated the FAQ available on the District's website would continue to be updated. He highlighted the changes occurring since January 19<sup>th</sup>. Mr. Slentz shared the next steps for the District regarding mandates.

Mr. Slentz reported the emergency regulations for testing unvaccinated staff had been extended through the end of May. He stated the regulation had been mandated by the NYS Department of Health. He stated the District would be utilizing the Saratoga County Department of Health for testing.

Mr. Slentz stated masks would be required for anyone testing positive following CDC guidelines. He shared the changes in regards to exposure, and stated masks and testing would still be available. Mr. Slentz stated positive cases have continued to significantly decrease within the District. Mr. Slentz shared other masking requirements and changes in methodologies.

Mr. Slentz discussed the District's proactive steps to meet the goal of staying in person. He also discussed Saratoga County's status as of 3/1/22.

Mr. Slentz shared the next steps for the District regarding mandates.

Mr. Slentz stated the District would be utilizing additional Federal funds to support overall wellness of students and staff, and to expand services for non-special education students. He gave a list of updated resources and stated the resource list was also available on the website.

**Elementary Reading Data Dashboard Overview**

Mr. Slentz discussed the importance of grade level reading proficiency. He stated the District was working to increase efficiency and effectiveness. He stated it was important to have explicit intentional and systematic ways of teaching. He reminded everyone that most initiatives take 3-5 years to implement.

Kathleen Skellie discussed high quality curriculum and data informed decisions. She discussed benchmark assessments and the diagnostic tools being used. Ms. Skellie explained the cycle of the assessments and tools. Ms. Skellie discussed the importance of consistency in programing and its impact on students. She shared snapshots for each of the grades for both diagnostic tools. Ms. Skellie discussed historical information impacting each of the grades. She discussed equity, access and multi-tiered systems of support for students in grades K-5. She highlighted tools being used to track and plan for student success.

Katie Whittemore stated she was proud of the work the teachers and students are doing.
