CALL TO ORDER

Susan Filburn called the Board of Education meeting to order at 7:00 pm

RECOGNITIONS

Mr. Slentz announced it was Music in our Schools Month, and that Mrs. DeRagon would be retiring this year.

Mrs. DeRagon recognized the students in music programs and highlighted the events students had participated in this year. She stated the entire music staff were honored to work with the students in the various programs, and that everyone was always proud of their performances and behavior. Mrs. DeRagon thanked the board, staff, parents and community members along with the students for their commitment.

The Music Department voiced their appreciation for Mrs. DeRagon's commitment and dedication to the program.

Mr. Slentz spoke about the importance of music and the arts for students' wellbeing and achievement.

A student from the Newsies Production announced the times and dates of the performance, and the group performed a number from the show.

Joe Lopez thanked everyone involved in the performance and invited everyone to attend.

SUPERINTENDENT'S REPORT

Ken Slentz stated that Ms. Mathias was heading up projects to look at different issues within the district, the first of which was attendance.

Ms. Mathias discussed the Attendance Project and the action plans contained within it. The action steps that have been completed were shared along with some of the information that had been discovered. She handed out packets to the Board that had gone home to families.

Brian Sirianni provided a report on the development of the FY2020 budget. He discussed the current standing of State Aid and explained the Comptroller had been, by law, responsible for submitting an estimate of state revenues for next year. Mr. Sirianni stated the amount was lower than expected.

Mr. Sirianni discussed the Tax Cap Calculation, explained the growth and changes within the district, and gave the estimated tax levy cap.

Mr. Sirianni discussed the draft budget and explained it was a rollover budget. He gave percentage increases and decreases in each of the components in the budget, and discussed the component breakdowns of general support, instruction, transportation and undistributed.

Mr. Sirianni stated special education costs were a major driver of costs in this budget. He stated the undistributed component was down 7.3% due to the change in debt service, and reminded everyone the High School had now been paid off. He stated special education costs had increased by 6.5%, and stated the district was reviewing the costs associated with special education.

Mr. Sirianni announced that an expense and revenue update would be given at the next meeting, and that the propositions would be shared along with a program update from the Superintendent.
