CALL TO ORDER

Jason Fernau called the Board of Education Meeting to order at 7:01 p.m.

RECOGNITION

Student Recognition

Mr. Slentz recognized the accomplishments of the Malta Avenue Odyssey of the Mind Teams. Students introduced themselves and shared their accomplishments, and announced they would be going to Iowa State University to compete in the World Event. Each student was given a certificate.

Mr. Slentz encouraged everyone to watch an Odyssey of the Mind event. He stated he was thrilled the District participates every year. Mr. Slentz thanked the mentors.

Mr. Slentz next discussed the Unified Sports Teams. He stated it was a huge pride point for the District that our student athletes give opportunities to students that may not otherwise have.

Dave Sunkus gave historical information on the unified program and shared information on the coaches and the teams. The coaches discussed the inclusion and the opportunities available. They stated the athletes were unified and how wonderful it was watching them all succeed. They shared information regarding the Unified Bowling Championship. Each team member was introduced and given a certificate.

Mr. Sunkus shared the academic and athletic achievements of all the teams. Mr. Sunkus recognized Coach Staulters, the varsity wrestling coach. Mr. Sunkus shared the accomplishments of the team and of individuals.

Mr. Staulters introduced the 3 wrestlers that had qualified and shared their accomplishments. Mr. Staulters stated the parents support the students and the team. He acknowledged the importance of their support.

Mr. Sunkus recognized a distance runner that qualified and will compete in the NYS Championships. He thanked the District for the opportunities being provided to the students.

Mr. Slentz stated it would not be possible without parents support. He thanked the parents for supporting their children and all the student athletes.

SUPERINTENDENT'S REPORT

Budget Update

Mr. Slentz stated no State budget had been approved. He stated the District was in a very good place. He stated there had not been many changes since the presentation on May 16th. Mr. Slentz stated the budget contained a 3.8% increase in spending, and an increase in the tax levy of 2.5%. He stated the budget supported all programs while putting additional academic and behavioral support in place.

Mr. Slentz discussed staffing, pilots and general funds. He gave a summary of proposed new positons for 2022-2023.

Mr. Sirianni gave the budget development update. He shared information on the undistributed portion of the budget. He discussed benefits and explained the figures. He included workers' comp, unemployment and life and disability insurances.

Mr. Sirianni next discussed debt service. He broke it down by type and explained each. He explained the savings of interest costs. He discussed the capital projects being done and the debt associated with each. He explained what was included in inter-fund transfers.

Mr. Sirianni shared the draft budget, the general support, instruction, transportation and undistributed components.

Brian Sirianni discussed the budget concerns and unknown factors. He discussed inflation, special education, interest rates, school lunch program and State and Federal budgets. He explained each and gave specific examples and specific of each concern.

Mr. Sirianni shared revenue information including State Aid. He shared a graph illustrating State Aid from 2008 - 2023.

Mr. Sirianni shared the draft budget total revenue and explained each of the revenue streams. He shared the tax levy cap calculation cap vs the actual tax levy. He stated the allowable amount under the tax cap was 4.6% and the actual amount was 2.5%. He explained the net effect on tax rates would be an average of approximately 1.0%.

Mr. Sirianni explained the next steps. He stated the budget adoptions would be on 4/13, the hearing would be on 5/4 and the budget vote would be on 5/17.

Mr. Slentz stated if the State budget passed, updates would be shared. He stated the District was fairly confident in the State Aid dollar amounts.

Mr. Fernau shared the District's contributions to the BOCES Administrative Budget. He shared information pertaining to BOCES and the upcoming BOCES vote.

Mr. Sirianni explained the support and efficiencies provided by BOCES.

COMMITTEE REPORTS

Mr. Turbiak reported the Communication Committee had been reviewing the strategic communication plan. He stated the focus was on website design and social media presence including the Scottie's Scoop.

Mr. Turbiak stated the Committee was working on the Scotties' Logo. He stated the District had been given a qualified approval for licensing. He added the District needed to start phasing out the current logo.

Mr. Turbiak reported the District was working on an end of year evaluation of communications. He stated there would be an internal Safety Committee Meeting next week to identify potential to emergency and crisis planning.

Mr. Slentz discussed the roll out for the new website. He stated the hope was to have it up and running by the next school year.

CORRESPONDENCE

Mr. Slentz shared the correspondence that he had received. He stated there was communication regarding custody, pickup's, BOCES, bullying on the busses and behavioral plans for ELA student.

Mr. Fernau shared the board correspondence was a letter praising Suessical and the staff members responsible for the production.
