SUPERINTENDENT'S REPORT

Kenneth Slentz discussed the School Closure Order. He stated under the order Districts were closed until May 15th. He stated that although other states had closed for the remainder of the school year, the Governor of NY had not yet committed to a full closure.

Mr. Slentz discussed the developing contingencies for end of year activities and the planning team's operating principles. He discussed the focus on health and safety of students and staff, keeping things simple, managing expectations, maintaining calm and communicating often. He discussed the NYS required plans including the child care plan, child nutrition plan and continuity of learning plan.

Mr. Slentz stated the annual budget vote had been delayed until sometime after June 1st. He stated the Governor had determined there would be no in person voting. He stated the District was waiting for the executive order to be released.

Mr. Slentz stated the District was anticipating significant cuts to State aid. He discussed the budget developments. He shared information regarding NYS's budget deficit. He discussed the tax levy increase in regards to the District growth factor. He stated the next budget presentation would be on May 6th.

Mr. Slentz stated that due to the budget gap, the seniority lists were being reviewed. He stated programming would also be reviewed.

Mr. Slentz discussed communication updates between schools and students. He discussed Phase 6 planning in the event that schools do not reopen in summer or fall. He stated the District was planning for multiple scenarios in regarding reopening. He highlighted the options being planned.

Dorothy Sellers thanked everyone in the District, including staff, parents, students, cleaners, and food prep and delivery staff for the hard work being done. She also offered thanks on behalf of the entire Board and reassured all that the Board recognizes the increased stress levels and urged all to take care of themselves.
