SUPERINTENDENT'S REPORT

Highlights from 2021-2022 School Year

Mr. Slentz stated his report was being shifted to the next meeting to allow for a presentation on shared common questions that had come after the Texas tragedy.

Mr. Slentz discussed the strategic points of focus in including positive student behavior and wellness. He stated this was a focus to maximize learning and a safe environment. He shared the items on post incident reviews. Mr. Slentz stated he had heard from a number of parents.

Mr. Slentz stated the District was always asking what could be improved. He stated the District was and is constantly upgrading and reevaluating to make improvements. He stated humility was necessary when looking for information to get improvement.

Mr. Slentz discussed safety plans, and noted where shareable information could be found on the website. He explained that building level plans were specific and confidential. He stated the confidentiality was to protect staff and students. He discussed some of the security features that

minimized access. He stated revision and unification plans were important for increased safety during and after events

Mr. Slentz discussed the District wide safety team, and shared the strategic partner list that lends their expertise to maximize safety for the District.

Mr. Slentz stated the District continues to support students and families with the counselors and mental health staff. He discussed importance of student behavior. Mr. Slentz shared the District's steps of threat assessments and discerning risk factors.

Mr. Slentz stated that when parents and students bring threats forward it has allowed situations to be shut down within 24 hours. Mr. Slentz discussed the changes in student suspension and re-admittance.

Mr. Slentz stated he would be making a video to go along with the presentation available on the website. Mr. Slentz shared the number of drills required and practiced.

Mr. Sirianni stated the District was making a schedule for building security checks.

Mr. Slentz stated the elementary SRO is shared between the 4 elementary schools. He stated vendors and all guests had rules to follow in the building. He shared some of the expectation list items for vendors and contractors.

Strategic Planning Update

Mr. Slentz discussed the progression of the District's work. He discussed and re-shared the Mission and the Vision of a Meaningful Diploma. He discussed and re-shared the District's Priorities and the Strategic Points of Focus. He discussed the curriculum development, recruitment, retention and development of personnel. Mr. Slentz discussed communications and the challenges related to communication, and also discussed long term planning.

Mr. Slentz revisited the draft goals for 2021-2022 and discussed the progress for curriculum, development and implementation, instruction, assessments and positive student behavior and wellness.

Mr. Slentz stated he was proud of the work and positive results the District had gotten regardless of the difficult situations presented in the last 27 months. He reminded everyone of the tremendous amount of work being done to allow and promote student growth.

Mr. Fernau reminded everyone this was a multi-year growth plan and commented on the importance of a multi-year program.
