Phase 3 Project Update

Mr. Slentz stated the Principals meetings would include discussion on reentry. Mr. Slentz stated it was the District's working assumption that the District would be fully opened in the fall. He stated the District would communicate any updates as soon as possible.

Mr. Slentz discussed State mandates in regards to wearing masks. He urged individuals to reach out to their representatives. He reminded everyone the mandates were coming from the State and not the District.

Mr. Slentz shared the good news that the District was on for a typical graduation at SPAC. He thanked Dr. Gianleo Duca for his hard work.
