SUPERINTENDENT'S REPORT

Dr. Dragone congratulated students and staff for winning 1st place at the Saratoga County Fair. He highlighted the awards that had been won.

Dr. Dragone stated the Taste of Malta had been a great event and thanked everyone that had attended. He reminded everyone that all proceeds come back to the district.

He went on to report all facilities projects were on schedule and looked great.
