CALL TO ORDER

Jason Fernau called the regular meeting to order at 6:59 p.m.

RECOGNITION

Mr. Fernau thanked Sheriff Zurlo and his team for investigating threat to the District. He stated they had worked quickly to locate and deem the threat as a non-threat. He thanked the investigators and resource officers.

Mr. Fernau noted that tax bills had been distributed. He thanked the community for supporting the programs of the District.

Mr. Fernau thanked the staff and principals responsible for open houses. He stated buildings looked great and great information was available for parents.

STUDENT COUNCIL

Student Council announced shirt orders were here and announced Spirt Week events and shared dates and times.

PUBLIC COMMENT

Crystal Horn, Greenfield Center, thanked the District for the communication that helped ease concerns on a day that could have been scary. She voiced her opinion on community tension and the ability to work together for safety and respect. She voiced support for a collaboration between parents, community, board and District. She voiced concern regarding blame on vulnerable students and community members while accommodations were being created.

Dr. Duca stated work had been started on a DEI Committee approximately 1 ¹/₂ years ago with the past superintendent. He stated he would provide an update once he had reviewed the information.



Mr. Fernau stated it would be appropriate for community members to reach out to Dr. Duca for opportunities to be involved with the committee.

Susan Westbrook, Ballston Spa School District, stated she was an ally for the LGBTQ+ community for years. She stated she supported collaborative work. She read from the policy and stated it contained clarity. She thanked the board for acting with integrity, applauded the efforts to be inclusive.

Kristofer DuBuque, Kaleen Dr. Ballston Spa, NY Informed, stated his group works to help Districts and Boards, and serves the greater community of Saratoga County. He thanked the Board, the Community, and the School Resource Officers. He commended the work being done to form bonds with students. He stated the Saratoga School District has concerns about having officers in the schools. Mr. DuBuque stated he has spoken in support of Resource Officers. Mr. DuBuque shared his experience regarding orientation and Officer Becker's presentation. Mr. DuBuque shared some models of a parent, board and community committee. He shared a handout with the Board.

Jared Iacolucci, 24 Chapman St, Ballston Spa NY, spoke in support of the gender identity policy. He reviewed the policy and discussed fear. He stated the Board was looking to build a safe place for everyone. He discussed the negative connotation surrounding comments at past board meetings. He stated the policy does not threaten, but enhances. He commended the Board and the District's administration for continuing to build a safe environment.

Jason Gurtler, Rowland Street, Ballston Spa NY, thanked the Sheriff's Office and the Mayor for handling the threat situation and communicating to the public in real time. He stated the District had not gotten the message out in real time, creating a fearful situation for some Mr. Gurtler also voiced concern regarding dress code during Physical Education. He stated girls were being targeted. He referred to a girls' coach that had been fired at another school district after making girls wear signs in class. He stated the coach currently works at the Ballston Spa District. He questioned back ground check policy.

Mr. Gurtler stated it was US Constitution Week. He read a law and stated it was required for schools to have an educational program between September 17-23 on the US Constitution. He stated the District should be following the law. Mr. Gurtler again asked for the School Board President to tender his resignation as a result of the letter that went out on August 4th for abuse of power, failure to uphold his oath and dereliction of duty.

SUPERINTENDENT'S REPORT

2022 Reopening Update

Dr. Duca reported students and staff are happy to be back at school. He stated routines were being established and reported positive feelings and student politeness throughout the District. He encouraged parents and care givers to attend Meet the Teacher events.

Dr. Duca stated the Transportation Office was working hard to resolve issues. He thanked those being affected by busing difficulties for their patience. He stated the District was working to hire more bus drivers.

Dr. Duca discussed the threat on Sunday evening. He shared a timeline of events including the message the District sent out Monday morning. He stated the District takes all threats seriously and investigates thoroughly. He encouraged anyone seeing or hearing of a threat to contact law enforcement immediately.

Dr. Duca stated building safety drills had begun across the District. He stated there had been a system issue and reminded everyone the drills are to test systems and to increase muscle memory for response from teachers, staff and students. Dr. Duca stated all systems were good to go moving forward.

Dr. Duca announced Rich Murphy as the High School Interim Principal and stated he would be a tremendous asset. Mr. Murphy was a former Shaker High Principal.

Dr. Duca stated homecoming would be exciting.

In response to a question from the audience, Dr. Duca explained the process and the available options for students unable to attend school due to a District transportation issue.

Bill McMordie of Saratoga Project Management gave a brief summary of the past phases, and the current phase of the facilities project. He highlighted past and current work at Malta Ave, Chapman St., Pine St. and Grove St. He also highlighted work that had been done at the Middle and High Schools.
