District Presents 2022-2023 Budget and Vote Information

PROPOSED BUDGET CONTINUES TO SUPPORT DISTRICT FOCUS AREAS

Each year the Board of Education focuses on the development of various policies to guide our daily work in providing safe, healthy, and welcoming schools that are full of excellent learning opportunities for each of our students. Although often not thought of as a policy, in fact the most important policy statement that the Board makes is the annual budget which provides the clearest signal of



the district's priorities relative to supporting the teaching and learning that takes place within our schools each day. This seven-month process begins in October and ends with the budget vote which is held on the third Tuesday of May each year.

In the intervening seven months, a great deal of planning takes place to ensure that we are finding an appropriate balance between providing our students with the best possible program that is within the confines of the taxpaying public. We believe that the budget that was presented to and adopted by the Board for the 2022-2023 school year accomplishes this balance while keeping a clear focus on the seven key areas of our strategic plan:

- **1.** The development and implementation of a strong and rigorous K 12 curriculum;
- 2. The effective delivery of instruction and, when students struggle to learn, instructional interventions;
- **3.** The use of well-designed assessments that provide us with critical information to improve teaching and learning;
- **4.** Promoting positive student wellness and behavior through explicit instruction and, when students struggle, effective interventions;
- **5.** The recruitment, retention, and development of strong personnel in all areas of district operation;
- **6.** The development of effective internal and external communications and communication tools: and
- 7. The ongoing development and maintenance of long-term plans in all major areas of district operations including curriculum, finance, and facilities.

PROPOSITIONS ON THE BALLOT:

Voters will consider the following separate propositions on the ballot:

Proposition I: School Budget

The district will be authorized to expend the sum set forth in its estimate of expenditures for the 2022-2023 school year in the amount of \$98,575,342 and to levy the necessary taxes therefore.

Proposition II:

School Vehicle Replacement

The district will spend up to \$920,000 to purchase and replace school buses and vehicles.

Proposition III:

Ballston Spa Public Library

The district will be authorized to collect and contribute \$60,885 towards the expense of operating the public library.

BOARD OF EDUCATION ELECTIONS:

There are two full term (three year)
Board seats up for election this year,
commencing in July 2022. Interested
voters will select from the following
candidates at the polls (in order of
appearance on the ballot): Lawrence
Ryan, Jason Gurtler, Christopher Zeppieri,

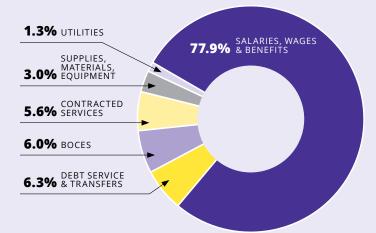
On Track for a Meaningful Diploma

Our district's primary goal is to have each of our students receive a meaningful diploma at the end of their educational career with us. For our students to achieve this, they need to be exposed to rich and rigorous learning materials and curriculum; to have strong supports to help remove barriers to their learning; to have a variety of pathways to explore their interests; and to have talented and committed faculty and staff to deliver effective instruction and provide consistent supports. The 2022–23 budget provides additional resources in each of these areas including:

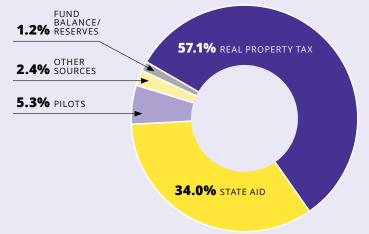
- The continuation of the implementation of and teacher training for our elementary academic and social-emotional curriculum;
- The continued development of and teacher training for the Middle School International Baccalaureate model of curriculum development, instructional delivery, and civic readiness;
- The continued expansion of our Career and Technical Education (CTE) courses and pathways and the addition of interest-based courses for high school students;
- The addition of social, emotional, and behavioral support personnel and programs;
- The expansion of program support for students with disabilities;
- The expansion of pathways for students who need alternative models of high school including Spa Academy;
- The restoration of music faculty positions which had previously been reduced; and
- 8. The implementation of an administrative model for special education that provides the necessary focus and support for students, families, staff, and principals.

We believe that this work is and can only be done in true collaboration with our families, our community, and of course, our staff. And as we go about our work together, we believe that we must have a shared mindset that each year we commit to doing better than the year before by taking advantage of our own opportunities to learn and improve. We believe that serving as role models for lifelong learning for our students can only further the likelihood that they will in fact earn a meaningful diploma.

The annual budget vote for the fiscal year 2022-2023 by the qualified voters of the Ballston Spa Central School District, Saratoga County, New York, will be held at the Ballston Spa High School for voters in District 1 and the Malta Town Hall for voters in District 2 on Tuesday, May 17, 2022 between the hours of 7:00 a.m. and 9:00 p.m., prevailing time, at which time the polls will be opened to vote by voting ballot or machine.

Vote May 17, 2022

The annual statewide School Budget Vote and Board of Education Elections will be held on May 17, 2022 from 7 am-9 pm. District residents vote at Ballston Spa High School (residents of the Towns of Ballston, Milton and Charlton) and the Malta Town Hall (residents of Malta).

The Bottom Line:

The adopted 2022-2023 budget for the Ballston Spa Central School District is \$98,575,342 which represents a 3.8% increase in expenditures over the 2021-2022 budget.

The projected tax levy increase to support the 2022-2023 budget is \$56,248,499, which represents a 2.46% increase over the 2021-2022 tax levy.

The tax impact on the average home in the district assessed at \$262,000 is projected to be \$68 per year.

The adopted budget supports all current programs in place and adds additional staff support for both academic programs, as well as for struggling and accelerated students.

District Budget and Vote Information

The Board of Education approved the proposed 2022-23 school district budget at the April 13, 2022 meeting. The annual statewide School Budget Vote and Board of Education Elections will be held on May 17, 2022 from 7:00 am – 9:00 pm. District residents vote at Ballston Spa High School (residents of the Towns of Ballston, Milton and Charlton) and the Malta Town Hall (residents of Malta).

The mandated School District Annual Budget Hearing is scheduled for May 4, 2022 at 6:30 pm in the Ballston Spa High School Library. It will also be broadcast on the district's YouTube channel. Questions may be submitted via email at boe@bscsd.org

If a resident of the school district meets the definition of a "qualified voter" but has not registered to vote, (s)he must register to be eligible to receive a ballot. A qualified voter may register with the county by contacting the Saratoga County Board of Elections, or at the district's registration day on May 10, 2022.

Absentee ballots are available for voters who are unable to visit the polls on May 17, 2022. An application for the absentee ballot is available for pickup at the District Office or by calling 518-884-7195 ext. 1320. Absentee ballots must be received no later than 5:00 pm on May 17, 2022.
